Concern 1: Anonymous

I am concerned that the College has not put out an official announcement regarding news reports and rumors about ICE visiting educational institutions. I think the lack of a statement from the College leadership is highly discomforting. I happened to be a guest at the Germantown Campus Council meeting where a similar concern was brought up amongst

faculty, and the answer was that faculty should talk to their Department Chairs. Well, what about the rest of us who aren't faculty and don't have Department Chairs? Also, that's not how information should be distributed. We shouldn't have to search or ask for it. I'm also concerned that our students aren't seeing any type of statement from College leadership. I'm frankly disappointed that a College who prides itself on being a minority-serving institution and requiring Anti-Racism training has not released any kind of official statement.
