

Student Government Leadership Badge Rubric

The Student Government Leadership Badge validates that the earner has demonstrated the ability to represent the student body effectively, collaborate with peers to achieve common goals, and advocate for student concerns within their institution. The earner has shown proficiency in leadership and interpersonal skills, including the ability to coach and develop others, organize and prioritize tasks, and contribute to ethical decision-making. To earn the badge, a student must achieve a score of at least 15 points, with all competencies rated at "Competent" or above. The competencies listed and measured are adapted from the [NACE Career Readiness Competencies](#) to ensure students develop the essential skills for success in leadership roles and future careers.

Governance and Decision-Making: Demonstrates an understanding of student governance structures, decision-making processes, and student representation. Collaboration and Team Leadership: Demonstrates the ability to collaborate with peers, lead projects, and contribute to team success. Strategic Planning and Problem-Solving: Demonstrates the ability to set goals, develop plans, and address challenges.	Develop project plans using appropriate digital tools, identify student concerns, participate in problem-solving discussions, evaluate projects.	Limited involvement in strategic planning. Struggles to identify challenges or contribute to actionable solutions.	Contributes to strategic planning and problem-solving efforts. <p>Civic Engagement and Ethical Leadership: Demonstrates ethical leadership and engages in civic initiatives that benefit the campus or community.</p>	<p>Organize or participate in civic engagement activities, promote initiatives, engage in ethical leadership discussions.</p>	<p>Limited participation in civic engagement. Struggles to demonstrate ethical awareness or contribute meaningfully.</p>	<p>Participates in civic engagement activities and demonstrates ethical decision-making. Eligibility: Any student actively involved in student government is eligible to earn the Student Government Leadership Badge. To qualify, students must provide documented evidence demonstrating that they have met the required criteria across all competencies outlined in the rubric.

To earn the Student Government Leadership Badge, students must achieve:

- At least **15 points** across all competencies with a rating of Competent (3) or higher in each competency.
- Submission of supporting documentation or reflections for selected activities.

By earning this badge, students demonstrate their ability to lead, collaborate, advocate, and engage ethically within their campus community, preparing them for future leadership roles and career opportunities.
